# **APPROVAL OF AGENDA**

Board Chairman George Quigley called the meeting to order at 1:32 p.m. Mr. Quigley reviewed the agenda for the meeting and inquired as to any additions. Mr. Shope made a motion to approve the agenda. Ms. Bowen seconded the motion. The motion passed unanimously.

## **MINUTES OF PRIOR MEETINGS**

# BUSINESS DEVELOPMENT MANAGER REPORT/COACH'S REPORT

Mr. Goldstein began his report by expressing his appreciation for the IAM membership's effort at the 2024 GRIN Spring Championships and 2024 USMS Spring Nationals. He noted that there will be a mandatory coaches meeting on August 19, 2024 to discuss various aspects of the program to solicit ideas for how IAM can improve in the future. Mr. Goldstein indicated that the evening practices at Riviera will be moving to 5:45 p.m. on August 12<sup>th</sup> for the remainder of the Summer season. He also noted that a short course meters competition will be held at the IU Natatorium in November 2024. Lastly, Mr. Goldstein discussed ongoing preparations for Swimcation in February 2025.

# **FINANCIAL REPORT**

Ms. Harter presented the financial report and distributed profit and loss statements and balance sheet to the Board for review which are current through June 30, 2024. Ms. Harter indicated that the program remains in a good cash position. IAM currently has \$176,277 cash on-hand. Total program income to date is \$124,807. Ms. Harter stated that IAM has not yet received payment from ISC for services rendered during the 2024 USMS Spring Nationals, but a final meeting is currently scheduled with ISC on August 8, 2024. Mr. Halbert noted that under IAM's agreement with ISC, final payment for services is due on or before August 30, 2024 contingent upon final settlement with USMS. Ms. Harter highlighted that IAM currently has approximately 299 dues paying members, which represents an increase of approximately thirty-two (32) members over
